### MEMORANDUM OF UNDERSTANDING

#### 1. INTRODUCTION

THIS MEMORANDUM OF UNDERSTANDING ("Memorandum"), dated 4<sup>th</sup> of December 2021, between Sardar Patel Technology Business Incubator (SP-TBI) and Don Bosco Institute of Technology, Mumbai (DBIT), collectively referred to as "the Partners".

#### 4. RESPONSIBILITIES OF Sardar Patel Technology Business Incubator (SP-TBI)

- SP-TBI has launched its NIDHI PRAYAS and NIDHI-SSS Initiative and sourcing startups and ideas for grant funding.
- SP-TBI will support early stage in its mission to source promising startups and ideas in Technology space.
- SP-TBI will provide the startups with funding opportunities, incubation facilities, mentoring guidance, and networking opportunities.

#### 5. RESPONSIBILITIES OF Don Bosco Institute of Technology, Mumbai (DBIT):

- Don Bosco Institute of Technology, Mumbai (DBIT) will work as sourcing partner to Sardar Patel Technology Business Incubator (SP-TBI)
- Don Bosco Institute of Technology, Mumbai (DBIT) will promote Sardar Patel Technology Business Incubator (SP-TBI) in college and its alumni network.
- Don Bosco Institute of Technology, Mumbai (DBIT) will invite Sardar Patel Technology Business Incubator (SP-TBI) for conducting sessions in college.
- Don Bosco Institute of Technology, Mumbai (DBIT) will organize selection sessions on behalf of Sardar Patel Technology Business Incubator (SP-TBI).
- Don Bosco Institute of Technology, Mumbai (DBIT) will launch a campaign to source ideas for NIDHI PRAYAS within Students of the College and alumni network.
- Don Bosco Institute of Technology, Mumbai (DBIT) will follow the timelines provided by Sardar Patel Technology Business Incubator (SP-TBI).
- There is no commercial obligation from Don Bosco Institute of Technology, Mumbai (DBIT) to Sardar Patel Technology Business Incubator (SP-TBI)
- Don Bosco Institute of Technology, Mumbai (DBIT) will submit quarterly report on progress on join initiative of Nidhi-Prayas to Sardar Patel Technology Business Incubator (SP-TBI)

- Sardar Patel Technology Business Incubator (SP-TBI) will mentor to start preincubation at Don Bosco Institute of Technology, Mumbai (DBIT)
- Sardar Patel Technology Business Incubator (SP-TBI)'s logo shall be displayed on the promotional materials, leaflets, etc. related to the proposed initiative.
- Don Bosco Institute of Technology, Mumbai (DBiT) should display a banner with Sardar Patel Technology Business Incubator (SP-TB!) as associate partner in the incubation setup by the institute.

#### 6. <u>USE OF INTELLECTUAL PROPERTY</u>

The parties agree that any intellectual property, which is jointly developed through activities covered under this MoU, can be used by either party for non-profit, non-commercial purposes without obtaining consent from the other and without any need to account to the other.

All other intellectual property used in the implementation of the MoU will remain the property of the party that provided it. Either party for purposes covered by the MoU can use this property but prior consent will be obtained from the owner of the property before using it for purposes not covered by the MoU.

#### 7. EFFECTIVE DATES AND AMENDMENTS.

This MoU shall take effect upon signing by both Parties. Neither party may assign or transfer all or any portion of this MOU without the prior written consent of the other party.

The provisions of this MoU may only be amended or waived by mutual written agreement by both Parties.

The individuals signing this MoU on behalf of their respective entities represent and warrant (without personal liability therefor) that upon the signature of each, this MoU shall have been duly executed by the entity each represents.

#### 8. TRANSFER OF FUNDS.

The parties acknowledge and agree that this MoU does not create any financial or funding obligation on either party.

#### 9. NO JOINT VENTURE

Notwithstanding the terms "Partners" and "Partnership", the Partners agree that they are not entering into a Legal Partnership, joint venture or other such business arrangement, nor is the purpose of the Partners to enter into a commercial undertaking for monetary gain. Neither Partner will refer to or treat the arrangements under this MoU as a Legal Partnership or take any action inconsistent with such intention.

## 10. NON-DISCLOSURE OF CONFIDENTIAL INFORMATION

Confidential Information: Sardar Patel Technology Business Incubator (SP-TBI) and Don Bosco Institute of Technology, Mumbai (DBIT) may change from time to time, and at their sole discretion, disclose to the other certain Confidential Information for the sole purpose of this Agreement. Sardar Patel Technology Business Incubator (SP-TBI) and Don Bosco Institute of Technology, Mumbai (DBIT) mutually agree to hold such Confidential Information in strict confidence and such Confidential Information shall not be disclosed to any other person other than in connection with Sardar Patel Technology Business Incubator's work for Don Bosco Institute of Technology, Mumbai (DBIT) under this MOU.
