MEMORANDUM OF UNDERSTANDING FOR PARTNERSHIP AND COLLABORATION

This MOU is made and executed at Mumbai at this date of 13 November of the year 2019.

BETWEEN

iRobokid is seeking collaboration with **Dept. of Electronics & Telecommunication, Don Bosco Institute of Technology** on technologies available with **iRobokids**.

The **Dept. of Electronics & Telecommunication**, established under **Don Bosco Institute of Technology Mumbai**, hereinafter referred as **EXTC-DBIT**; (which expression unless excluded by or repugnant to the subject shall mean and include its successors and assigns), is a premier private engineering institute established in 2001 by the Bombay Salesian Society for imparting high quality engineering education in the fields of Electronics and Telecommunications Information Technology, Computer Engineering and Mechanical Engineering at Automobile Road, Kurla(West), Mumbai 400070, Maharashtra.

AND

iRobokid, (which expression unless excluded by or repugnant to the subject shall mean and include its successors and assigns), is an organisation specialising in STEM education, aiming to provide the latest in STEM education. **iRobokid** team comprises of over 25 trained instructors & educators with a mix of experience of teaching and background education of engineering. **iRobokid** has education collaborations with partners in USA, Germany & China enabling to offer the latest in STEM education across the world. **iRobokid** currently offers 6 different programs for age group 6 – 14 years and plans to add 1 new program every year.

Whereas, both **EXTC-DBIT** and **iRobokid**, now recognizing that mutual collaboration, given each other's strengths in expertise and facilities thereof, will mutually benefit the students and faculties of **EXTC-DBIT** and **iRobokid**. Now, therefore, the parties here to have agreed to enter into a Memorandum of Understanding (MOU) in consideration of the mutual promises made herein and of good and valuable consideration, the receipt and sufficiency of which both **EXTC-DBIT** and **iRobokid** hereby acknowledge. **EXTC-DBIT** and **iRobokid** hereby agree to sign a memorandum of understanding (MOU).

It is mutually agreed by and between the parties as under.

A. Scope Of The Collaboration:

I. Validation of Robotics Club & School of Automation (RCSA) - Course on robotics, Automation and IOT (CRAI) :

- a. **iRobokid** can give suggestion, scope of improvements, procedures to be followed so as to validate the RCSA-CRAI course as per STEM pedagogy.

II. Internships For Students:

- a. **iRobokid** would accommodate **EXTC-DBIT** students who have completed the **CRAI**, conducted by **RCSA** of **EXTC-DBIT** for a certified internship.
- b. The number of internships and duration of each internship can be mutually decided by both parties.

III. Mutually organising robotics competition for school students of Mumbai region:

- a. **iRobokid** and **EXTC-DBIT** would collaborate to organise the robotics competitions for schools in **DBCL** campus as per management policy.
- b. **EXTC-DBIT** will provide student volunteers to co-ordinate the event and logistic support in form of space to conduct the event, as per prevailing policies of institute.
- c. **iRobokid** will involve **EXTC-DBIT** students for planning, execution and implementation of the event.

IV. Student placement:

- a. **iRobokid** can give preference to deserving students of **EXTC-DBIT** in hiring.

Co-ordinating Committee:

There will be a co-ordinating committee consisting of Head of the Dept. of **EXTC** , **RCSA** co-ordinator and Directors of **iRobokid** who will be responsible for the effective implementation of the **MOU**.

If any charges/ expenses are to be paid by either organization for the facilities provided by the other organization, such will be decided by the co-ordinating committee by a separate 'Rentals and Services Agreement' which also may be modified from time to time as per the need.

V. Duration:

The **MOU** is valid for a period of **36** months from the date of signing.

VI. Termination:

Either party is free to terminate the agreement by giving a notice of **1** month.

VII. Governing Law:


